

**APPLICATION FOR A
DRILLING PERMIT**

General Instructions: A Drilling Permit is required by the District for drilling a new groundwater well. A drilling permit is also required for the following: perforating an existing well, replacement of an existing well, increasing the size of a well pump therein so that the well could reasonably be expected to produce 25,000 gallons per day or more, unless the well is an exempt well under District Rule 11.3. An application for a Drilling Permit shall contain all the information requested in Rule 11.9, and may be filed with a Drilling Permit Application for more than one well.

If the Applicant is more than one individual with different residences, attach a separate sheet with a description of their respective interests in the well(s), listing their names and addresses, and designating a contact person. If the Applicant is a corporation, partnership, limited partnership or other business association, state its name and address below and attach written documentation that the Authorized Representative, whose name is provided below, is authorized to represent the well owner. If the applicant is other than the owner of the property, attach documentation establishing the applicable authority to construct and operate a well(s) subject to this application.
