CONSOLIDATED DRILLING AND PRODUCTION PERMIT HEARING for ROBERT SADLER AND FRANK LIGON FOR A 2 WELL SYSTEM ON BLOCK 51-10, SECTION 8 IN PECOS COUNTY, TX.²

 Call to order at 1:04 p.m. on Public Hearing on Consolidated Drilling and Production Permit Application for Robert Sadler and Frank Ligon for a 2 well system on Block 51-10, Section 8 in Pecos County, TX. Permit Request: 30 acre feet/year from the Edwards Trinity Aquifer. The 2 proposed wells are located on T&P RR Co Block 51-10 Section 8 in Pecos County, TX. The wells are projected to be 600 ft in depth, and drilled into the Edwards Trinity Aquifer. The purpose of the proposed wells is for Industrial Use.

Board member Alvaro Mandujano, Jr. recused himself from proceedings due to a conflict of interest. (Disclosure Affidavit signed)

Party representing application: Bob Sadler

Protestant to application: Bob Hayter provided verbal comment on October 21, 2014. He was unable to attend today's hearing and submitted written comments along with a map depicting his well locations. His letter dated 11-17-2014 requested that it be part of the record that his family strongly protests any commercial station this close to their ranch and home.

Public comment: Ed McCarthy, on behalf of Fort Stockton Holdings, registered the following written comments: (Summarized) Based upon its real property interests and regulatory rights, FSH has legal rights, privileges and economic interests within the District's regulatory authority that may be adversely affected by the Applicants proposed permit.

Paul Weatherby presented the application to the Board. MPGCD will have 2 monitor wells in the area – one on Bob Hayter's ranch and one on the Interstate. He asked that a special condition be added to the permit application, which is that MPGCD will install a tremmie pipe to get drawdown and static levels and the transducer would be at the cost of MPGCD.

Bob Sadler: If sufficient water is obtained with the first well drilled, he may not need 2 wells. At this time, he requests that the application be approved as presented for 2 wells at 30 acre feet for the 2 well system.

II Adjourn hearing and consider and/or act on **Consolidated Drilling and Production Permit Application for Robert Sadler and Frank Ligon for a 2 well system on Block 51-10, Section 8 in Pecos County, TX.**

Ty Edwards presented the application to the Board. He has been farming 183 acres for years with these wells. The wells pump 880 gallons per minute. When we called Mr. Dutton about needing to get a production permit, he came in immediately. The application is administratively complete.

If they do not get the Brine permit, they want to sell fresh water. They want to haul 1,000 barrels per day. There is not a monitor well in the area.

DRILLING PERMIT HEARING for STW Water Process & Technologies²

Call to order at 1:43 p.m. on Public Hearing on **Drilling Permit Application for STW Water Process & Technologies.**

Proposed Test Well is located approximately 12 miles Southwest of Fort Stockton on Old Alpine Hwy on T&P RR Co Block 3, South East section 112 in Pecos County, Tx. The proposed well will be drilled to +/-4,000 ft into the Capitan Reef Aquifer.

Party representing application: Alan Murphy and Raul Rodriguez

Protestant to application: None

Public comment: Ed McCarthy, on behalf of Fort Stockton Holdings, registered the following written comments: (Summarized) Based upon its real property interests and regulatory rights, FSH has legal rights, privileges and economic interests within the District's regulatory authority that may be adversely affected by the Applicants proposed permit.

Paul Weatherby presented the application to the Board. This test well is in addition to the test well approved on 09-16-2014. It will be on the same section of property owned by the City of Fort Stockton. There is a signed agreement giving STW Water Process & Technologies the authority to drill. They are expecting 1,500 to 2,500 gallons per minute, and if the well good – they will come back to the Board requesting a production permit with authorization to export, and possibly for industrial use also. The well is being drilled to Texas Commission on Environmental Quality regulations for a potable water well.

II Adjourn hearing and consider and/or act on **Drilling Permit Application for STW Water Process & Technologies.**

Jerry McGuairt adjourned the hearing at 1:55 p.m.

Ruben Falcon made a motion to approve the Drilling of the Test Well located approximately 12 miles Southwest of Fort Stockton on Old Alpine Hwy on T&P RR Co Block 3, South East section 112 in Pecos County, Tx. The well will be drilled to +/-4,000 ft into the Capitan Reef Aquifer. Motion was seconded by Alvaro Mandujano, Jr. Motion carried unanimously.
