X Update on **San Andres flowing** well issues around Imperial area.

General Manager Ty Edwards updated the Board on the plugging of the flowing well on Highway 1053 and 1450. The District and local landowners are starting to make progress in plugging the flowing wells and address environmental issues around Imperial. Boehmer Lake was also discussed. RRC has recently began an investigation into the possibility of plugging this well with state funds.

XI Update on FSH-MPGCD Joint Study and Implementation.

Telemetry units have been installed in two additional wells: the City of Fort Stockton Capitan Reef Monitor well and FSH S-34 Rustler Monitor well. Both wells have been added to the hydro-vu link and are recording pressure and conductivity.
