Notice is hereby given that Pecos County Precinct 3 has made application for a **Drilling Permit** with the Middle Pecos Groundwater Conservation District for **2 wells** located on **149.14 acres (Property Id# 38064) Legal Description: 731 1 I&GN SEC 65**, approximately 1 mile West of Iraan at the Pecos County Golf Course, in Pecos County, Texas.

The wells are projected to be **200-400 feet in depth and drilled into the Edwards Trinity Aquifer. The estimated rate of withdraw is 2 wells at 50 gallons per minute and the purpose of these wells will be for Irrigation Use.** The Hearing will be held on **February 18, 2020 at 10:00 a.m.**, at 405 North Spring Drive (MPGCD Office), Ft.
